BME Group's Back-Up Data Center migration

In relation to the notice sent on March 20 about the upcoming migration of the Back-up Data Center, we remember that BME will move the Back-Up Data Center located in the Plaza de la Lealtad to the Equinix building located in Alcobendas, specifically to the Equinix MD6 site. BME members who currently have connections to the Equinix MD2 site will be able to make the connection from this MD2 site to the MD6 site. Annexed to this notice you can find the list of line providers (carriers) on both sites.

Looking ahead to the upcoming months, these are the actions required by BME members:

- Members with **lines managed by themselves** who currently have circuits ended on the Plaza de la Lealtad site, must **request the transfer of the circuit** or the constitution of a new one on the Equinix MD6 site. This change must be effective between the second half of November and the first half of December, so members are required to start contacting the carriers as soon as possible.
- In the case of members with **lines managed by BME**, it is **not necessary to make any changes/operations**. Between November and December 2024, BME will move all Lealtad lines supervised by BME to the new Back-up Data Center at Equinix.

All these changes will always be made on the weekend, with the markets and other BME infrastructure closed.

- Each change must be made in coordination with the affected members, who will be required to carry out a mandatory connectivity test to ensure that their connection to the new Equinix Back-up Data Center works correctly in the session of the following Monday.

BME will inform the members affected by each of the transfers with enough time so that they can prepare the aforementioned mandatory connectivity tests.

We also remember that:

- London Hub and VPN Access: BME will make the necessary changes.
- Colocation and proximity: no changes required
- The IP address of servers and VPN connections will not be affected.
