

## NOTICE MEFF 17/2025

CIE AUTOMOTIVE S.A. – Adjustment to Futures & Options Contracts



9 April 2025



The Spanish Securities Market Commission (CNMV), in an "Other Relevant Information" published on April 8<sup>th</sup>, informs about the request for the authorization in relation to the voluntary and partial takeover bid for CIE AUTOMOTIVE, S.A. (CIE) of its own shares.

The offer will be made on 9,675% of the shares of CIE, at a price of 24,00 euros per share in cash.

MEFF informs that new maturities of Naturgy futures and options shall not be opened until the end of the takeover.

According to sections 4.7.1.9 y 5.7.1.9 of the General Conditions of the Financial Derivatives Segment, MEFF will ask to the Supervision and Surveillance Commission, once the corresponding prospesctus has been published, to determine the result of the CIE takeover bid that must be fulfilled with the adjustment of the futures and options contracts.

In the case of settlement of the open position at theoretical value, MEFF will take as a reference the parameters set in Annex 1.



## Annex 1

On March 20<sup>th</sup> at 18:04 CET, after the market closes, the preliminary announcement of the Public Tender Offer was made, so according to the General Conditions of MEFF, the data to be used for the calculation are as follows:

- Underlying asset price: Takeover price will be applied.
- ATM price reference: average closing price from 14<sup>th</sup> to 13<sup>th</sup> of March: 22,37 euros.
- Dividends: Estimated dividend payments as of March 20<sup>th</sup> 2025.
