Conditions for introducing the Exercise Price series in the standard Stock Options Contracts

This Instruction is published to develop what is established in point 5.6.1 of the General Conditions of MEFF.

MEFF will introduce series into the system in a way that at least five Exercise Prices can be traded for each expiration at all times.

As a general rule, the intervals of the Exercise Prices will be those expressed in the following table, although MEFF may whenever it deems appropriate, at the request of a member or to respond to market needs, introduce different series of Exercise Prices.
